NPU-D Report

The June 28 th NPU-D meeting was quiet. We ran slightly past our designated 9:00 PM end time because of a lengthy question-and-answer session with City Council President Lisa Borders, who was there in her capacity as Council President rather than as a mayoral candidate (the NPUs are not a political forum). The discussion was fairly wide ranging and touched on several topics where more information was required. Notable among these was the recent article in the Sunday Paper that criticized the implementation of the city's water meter replacement program (<http://www.sundaypaper.com/More/Archives/tabid/98/articleType/ArticleView/articleId/4306/All-wet.aspx>). What was noteworthy about this article is that, based on the figures presented, the program is fundamentally unsound in a fiscal sense. If everything had gone perfectly, we would all still have lost money for choosing to do it in the first place or so it seems. Lisa did not know the details of this, but she promised to investigate it and get back to us.

The only zoning case on the agenda was a front-yard setback variance in Underwood Hills that we had deferred two or three times before. We finally dealt with this by approving it with a further reduced front yard depth to 25 feet so as to shift the proposed new house forward on the lot. This was done so that it would match the neighboring houses and minimize the invasion into a stream buffer in the back yard.

We endorsed an ordinance modifying zoning codes with new definitions of "self-storage facilities". These changes did not seem to be of any great consequence. We disapproved of an ordinance that would allow private companies that boot cars to increase their fees from \$50 to \$75. No one could see any reason why an increase was necessary or what public good these companies served. The lone dissenting opinion on this was from a resident whose church receives revenue by having cars booted in its parking lot. Clearly, if this practice has been endorsed by God, then we may all be in for a good smiting for opposing it.

In a surprise last-minute addition to the agenda, we discussed and endorsed a resolution advocating for the new Northwest Library branch to be located on the site of the failed Burtz St development (at the corner of Burtz and Hollywood Rd in Riverside). Most of the discussion on this focused on the propriety of making a last-minute change to the agenda, as everyone seemed to be in agreement that this was a good library location. Because of the public-input process, there was a deadline to submit proposed sites before our August meeting, so we voted to endorse the resolution. We will also place it on our August agenda, so that it can be properly advertised.

Watering Restrictions lifted

In light of the ending of the drought, Atlanta and the state of Georgia have lifted the restrictions on watering. Residents are asked to still adhere to a non-drought watering schedule, however. Odd-numbered addresses can water on Tuesdays, Thursdays and Sundays. Even-numbered addresses can water on Mondays, Wednesdays and Saturdays. Watering can occur anytime, but residents are asked to avoid watering landscape during the hours of 10 am to 4 pm because of its limited effectiveness (water evaporates too quickly in the heat of the day, and thus doesn't benefit the plants).
