Activity with our developers has heated back up. The tree hearing on Coro was tonight (Oct. 15). There was an agreement on the majority of the issues prior to the hearing and the committee voted to approve the agreement. Coro agreed to change the site plan to save between 15 and 20 trees on the northwest corner of the development. They also are adding some landscape and making a few other improvements such as eliminating the concrete retainer wall. They also agreed to take a 120 day review period to discuss the widening of Bellemeade. We will be having two public hearings to allow all of your opinions to be heard. We will be in touch with you when we got those meetings scheduled. Please be sure and thank Elizabeth Sears for her tireless efforts on our behalf. This has been a very time consuming and difficult effort for her and everyone who has been involved.

The negotiations with Selig begin again next Monday. Selig has reached an agreement with Costco on the retail

side and with A.G. Spanos on the residential side. Spanos will be at the negotiation on Monday and according the the Selig folks is very anxious to work with the neighborhood.

Master planning efforts are also underway. We have completed a survey of the residents and are in the process of compiling the results. The Georgia Conservancy has agreed to work with us using Georgia Tech students to help with a lot of the research work. Our goal is to produce a master plan that meets with the city LCI requirements. The LCI program has set aside funding for neighborhood improvements if the requirements for LCI master plans are met (I can send vou the details if vou would like). We will need to raise about \$40,000 to do the plan and we will need all the help we can get to do it.

The Georgia Conservancy and a representative from City Council President Cathy Woolard's office will both be speaking at our meeting next Monday. Please try to make time in your schedule to be there.


