Well, we have had a little too much excitement in our neighborhood over the last couple of weeks in regards to crime activity, and it is quite alarming. Starting November 15th, we have had four (4) home disturbances including theft or vandalism, three (3) cars being rifled through and items stolen, one (1) car stolen, and two (2) armed robberies. That's a total of ten crimes in a span of 26 days!

Sgt. Cooper, Officer Porter, and Officer Cook from the Atlanta Police department, Zone 2, were kind enough to address our concerns at the Crime Meeting Saturday morning, November 23rd. They had some great suggestions such as getting to know your neighbors and their activities so that you are aware when people are around their house while they are not supposed to be at home, calling in to 911 when ANYTHING suspicious is happening, and staying on the line to give them full descriptions of the individuals involved, keeping anything of value out of view in your car or in your home, leaving plenty of lights on inside and outside to make it harder for criminals to lurk around the neighborhood, etc., etc.

We as a neighborhood have revived the Block Captain Phone Tree system, and we have discussed selling Berkeley Park Crime Watch stickers to neighbors for \$2 a piece to adhere to mailboxes and let criminals know that we are watching them. Please let us know your ideas on this, if enough people are behind it we will do it.

You can do the most good this holiday season by finding out when your neighbors will be out of town, letting your neighbors know when you'll be out of town, doing the things that the police officers suggested above, and really being aware of your surroundings. The times for the crimes over the last month have been a mix between morning, daytime, evening, and late night, so obviously at

The Berkeley Park Executive Committee met with Bill Ranck of Ranck and Associates to discuss this developer's interest in the Castlegate site. Currently the property is under conditional contract which basically states the land is to be purchased IF the developer can successful obtain rezoning and other relevant impacts regarding proposed land use, anchor tenant and other undisclosed factors of the contract. Currently there is NO SITE PLAN and there is NO SITE PROGRAM. Bill met with the committee for the purpose of initial introductions and informal feed back as to some of the neighborhoods top concerns including traffic, apartment values, retail (big box) and other such factors discovered during the Home Depot battle. The meeting itself was very productive in terms of the developers attitude and understanding regarding working with the neighborhoods and cordial in our presentation of concerns. The next step will probably be the developer working on a site plan and continued conversations with the neighborhoods (ours and others) the NCA, the City of Atlanta and others. Basically we can expect a dialog between all arteries concerned. We will keep you posted as to schedule for workshops and look forward to everyone's participation.

Neighborhood Patrol


