# **NPU-D Report**

The April 27 th NPU-D meeting may have been the least eventful on record. There were only two business items on the printed agenda: a residential subdivision in Riverside and a liquor license for a new BBQ restaurant. The subdivision did not require a vote, and the liquor license was quickly and unanimously approved. We have a well deserved reputation for being the liquor-friendliest NPU in the city. The minutes from the meeting are appended to this article.

The meeting wrapped up before 8:30. We were supposed to have discussed two proposed ordinances dealing with towing fees and residential parking permits, but those were accidentally left off of our agenda by the city, so we skipped over them. It is unlikely that we would have had much to contribute to these anyway.

Just before the meeting wrapped up, Harry Leon announced that he had prevailed in his latest legal battle with CSX. This victory will not affect their handling of hazardous materials in the Howell rail yard. For that we will need city attorneys with fully formed spines. The issue in this case was CSX's contention that Harry had no standing to intervene in the enforcement process in the first place. They were essentially trying to force him to shut up by suing. The nature of this suit was both absurd and disturbing in its implications for democratic governance. CSX was never required to defend itself against Harry, as the enforcement issue was between Harry and the city. CSX's involvement in that case was largely motivated by their fear of having the matter go before a judge. This decision in Harry's favor sets a positive precedent for all of us to be involved in the city's code and zoning enforcement process.

For those who have not seen either the physical reality or the many related announcements, a section of Collier road adjoining Underwood Hills has been closed and will probably remain closed for most of May

( Ed. Note: the roadwork was completed and the road re-opened on May 10 ). The posted detour around this involves taking Defoors to Howell Mill, but those who proceed past the "detour" signs to the point of clsure are diverted onto Seaboard PI., Seaboard Ave, and Woodland Hills. This puts a lot of traffic (angry fast-moving traffic) onto these normally quiet residential streets, which are usually quite pedestrian friendly. A map showing the detour route is linked here. In a brighter note for pedestrians, the "yield to pedestrians in crosswalk" signs have finally been returned to the crosswalk at Howell Mill and White St where they were removed three years ago. I have not yet observed any cars actually yielding (in fact two of them accelerated toward me from 3 blocks away to force me back out of the crosswalk on the evening of May 4 th ), but at least now I can point to the sign telling them exactly which law they are breaking. Some drivers may even learn an important lesson before taking another life here (a pedestrian was killed in that crosswalk about 6 years ago).

On May 3 rd the Beltline Subarea 8 planning group met again. For the first time there were some actual plans presented at this meeting. This primarily involved proposed street connections, which were pretty much like those that we have seen before. There was no discussion of land use changes, minimal consideration of the future of the waterworks site, and no consideration of the future of the Chattahoochee Rd corridor. The city has acknowledged the need to preserve industrial land uses in our area, but unfortunately the planners have thus far taken this to be

a mandate for not planning. Apparently all of the planning with which they are experienced involves doing away with industrial uses, so this new ground for them. Perhaps plans presented at future meetings will give more serious consideration to the needs and desires of local industry.
